November 16-17 CISC General Membership Meeting Overview

Nearly 100 persons attended the final CISC General Membership meeting of 2017. Preparing for the launch of our new accountability system and the related State Systems of Support was the focus of [Day One](#) with presentations from SBE staff including Keric Ashley, Melanie Schoeppe, and Jeff Breshears. The approved [CCSESA Differentiated Assistance Protocols](#) were presented to and reviewed by members in their final format. Presentations by Tehama, Kern, and Placer Counties regarding internal improvement efforts were shared. Regional discussions regarding the constitution of differentiated assistance teams and capacity considerations were held and CISC members were introduced to a [Data Collection Survey](#) and [Differentiated Assistance Log](#) for the purpose of capturing information regarding this first phase of level two support to LEAs. The meeting concluded with presentations by Nancy Brownell on the alignment of WASC, LCAP, and SPSAs and Josh Daniels on current and planned CCEE efforts.

Agenda topics for [Day Two](#) were focused on Standards Implementation and included presentations from SBE staff Tom Adams and Barbara Murchison. Other presentations included an update from the Math Community of Practice, a West Ed Standards Implementation survey analysis and an Environmental Literacy overview.

Subcommittee Activity

The 14 CISC Subcommittees (Accountability, CTE, Digital Learning, ELA/ELD, History/SS, LCAP Directors, Leadership, Math, Assessment, School Readiness, Science, Symposium, Teacher Development, and VAPA) along with the various liaisons (Extended Learning, Business Partnerships, Charter Schools, Distinguished Schools, Language Policy, Legislative, and RSDSS) shared updates and information at the recent [November Virtual Meeting](#).
