Title 5, Sections 4600-4687 – Uniform Complaint Procedures (note: re: teacher vacancies, Section 4600 defines “beginning of the year or semester”)

Title 5, Section 9531 – Instructional Materials Funding Realignment Program (contains definition of “consistent with the content and cycles of the curriculum framework adopted by the state board” for purposes of meeting the requirements set forth in Education Code Section 60119)

Title 5, Section 17101 – “under review” definition for purposes of COE instructional materials sufficiency reviews (CCTC adopted this regulatory definition for purposes of “under review” exemptions from annual assignment monitoring as well – see page 10 of CCTC Coded Correspondence 05-0014, dated August 26, 2005:
